**EveryDay Learners (Education) - The ability to learn and read makes a difference for later success. We work with parents to ensure that all children are ready to start school and stay in school by funding internal and community partner operations to provide free or low-cost resources, including programs that help kids overcome delays and be ready for school, increase literacy with home libraries, tutoring and parent tools, and mentor high school students towards graduation. Last year, our Help Me Grow program served 1,909 children and performed 2,862 developmental and behavioral screenings to identify and provide referrals for growth development, communication and behavioral skills.**

**EveryDay Support (Income) - Families and individuals have a basic need of achieving financial stability. We work to empower them to reach sustainable income by funding internal and community partner operations to provide free or low-cost resources, including free income tax preparation, utilities and rent assistance, job skills training, adult computer literacy, and financial classes and counseling. In 2018, we brought back more than \$5.5 million in tax refunds into the community through the Volunteer Income Tax Assistance program, which will increase the stability and earning potential of those we serve.**

**EveryDay Strong (Health) - Anxiety and depression are on the rise in Utah County youth, and we are working to build resilient kids and strong communities by funding internal and community partner operations to provide free or low-cost resources, including programs that promote health education and child abuse prevention, support suicide prevention training, and provide parent training and education. Last year, we trained every school counselor in the Alpine and Nebo School Districts, potentially reaching 80,000+ children, and completed the infrastructure for a parent helpline.**
