Education - The ability to read at grade level makes a difference for later success, and third grade reading scores are a crucial barometer for a strong community in the future. We work to ensure that all children are ready to start school and stay in school by funding internal and community partner operations to provide free or low-cost resources, including programs that help kids overcome delays and be ready for school, increase literacy with home libraries, tutoring and parent tools, and mentor high school students towards graduation. As this work has progressed, we have seen a significant improvement of third grade reading scores in Utah County.

4b (Code:) (Expenses \$ **871,326** including grants of \$ **497,467**) (Revenue \$)

Income - Families and individuals have a basic need of achieving financial stability. We work to empower them to reach sustainable income by funding internal and community partner operations to provide free or low-cost resources, including free income tax preparation, utilities and rent assistance, job skills training, adult computer literacy, and financial classes and counseling. In 2017, we brought back more than \$4.7 million in tax refunds into the community through the VITA program, which will increase the stability and earning potential of those we serve.

4c (Code:) (Expenses \$ **1,006,989** including grants of \$ **140,661**) (Revenue \$)

Health - Anxiety and depression are on the rise in Utah County youth, and we are working to build resilient kids and strong communities by funding internal and community partner operations to provide free or low-cost resources, including programs that promote health education and child abuse prevention, early detection of developmental delays, support for kinship care providers, and parent education. Last year, our Help Me Grow program served 2,981 families and performed 3,039 screenings to identify and provide referrals for growth development, communication, behavioral and gross motor delays.
